WSE Member Agreement

This membership agreement is created between "Member" and Women Sales Experts ("WSE"). WSE runs a Business League, as that term is defined by 26 U.S.C. § 501(c)(6) pursuant to the laws of Colorado. Member wants to join WSE under the terms of this agreement as follows.

1. Membership

- 1.1. WSE accepts Member into membership effective as of the date below and continuing until such time as the Member ceases to be a Member in Good Standing as set forth below in Section 4, the Member terminates their membership as set forth below in Section 6.2 below, WSE terminates the membership as set forth below in Section 6.1 or WSE ceases to operate.
- 1.2. By executing the Agreement, Member agrees to the terms of membership, which may change from time to time.

2. Member Responsibilities

- 2.1. Member asserts that as of the time of execution:
 - 2.1.1. They are actively engaged in a business of sales consulting, coaching, speaking, and training, and
 - 2.1.2.A majority of the Member's income comes from a business of sales consulting, coaching, speaking, and training.
- 2.2. Member promises to follow the rules of this Agreement and of WSE including:
 - 2.2.1.Respect of other members' rights and privacy. Members shall seek other members' permission before using or posting another member's words, images or videos on any platform for whatever reason,
 - 2.2.2. Not to engage in activities that create a conflict of interest with WSE, and
 - 2.2.3.Comply with WSE Membership Committee rules as may be disseminated from time to time.
- 2.3. Participate in Member meetings as called from time to time and share expertise with other members as appropriate.

3. Dues

- 3.1. Member shall pay an annual Membership Fee as established by the WSE board of Directors on the 30th of January. The fee covers Cost of WSE administration and support functions as established by the WSE Board of Directors.
- 3.2. Supplemental activities as established by the WSE Board of Directors may require an additional fee. In the event that additional fees are required for participation in supplemental activities, Member has the option to pay those fees to participate. Non-payment of fees for supplemental activities does not impact the Member's Good Standing.

4. Members In Good Standing

- 4.1. Members shall be considered Members in Good Standing when the member meets the following qualifications on an annual basis:
 - 4.1.1.All Membership Fees are paid within 45 calendar days of the due date,

- 4.1.2. Member provides or works for a company that provides sales consulting, coaching, speaking, and training, and
- 4.1.3.A majority of Member's income is derived from work providing sales consulting, coaching, speaking, and training.

5. Renewal

- 5.1. WSE shall initiate Membership Renewal at least 45 days prior to the expiration of the Membership. Member shall renew their membership within 45 days of the expiration of their membership.
- 5.2. In the event that the Member fails to renew their membership, WSE shall remove the Member's name from the list of members, remove the member's access to all WSE electronic accounts and remove the member from distribution lists until such time as the Member is in Good Standing.
- 5.3. If the membership lapses, Member shall rejoin WSE by following all procedures in place at the time the Member wants to rejoin WSE.

6. Termination

- 6.1. WSE shall terminate the Member's membership upon the following by a quorum vote of the WSE Board of Directors:
 - 6.1.1. Unpaid Membership fees,
 - 6.1.2. Change in Member's work requirements as set forth in Section 2.1.2, and
- 6.2. Member may terminate their membership at any time for any reason by providing the Membership committee written notice, provided however, that the membership fees shall not be refunded for any reason whatsoever.
- 6.3. Upon termination for any reason, WSE shall remove the Member's name from the list of members, remove the member's access to all WSE electronic accounts and remove the member from distribution lists.
